




171-11, Hawaii Revised Statutes, as amended, do hereby order that the following described land, identified as "Withdrawal Portion of Agriculture Purposes Site, Governor's Executive Order 4239," situate at Waimanalo, Koolaupoko, Oahu, Hawaii, containing an area of 5303 square feet, more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, being designated as C.S.F. No. 25,390 and dated September 11, 2014, is hereby withdrawn from the Operation of Governor's Executive Order No. 4239 dated September 17, 2008.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

Being a portion of the Government (Crown) Land of Waimanalo.

Being also a portion of Lot 67 of Waimanalo Farm Lots.

Beginning at the southeast corner of this parcel of land and on the northwest side of Kumuhau Street, the coordinates of said point of beginning referred to Government Survey Triangulation Station "WAIMANALO RIDGE" being 2927.82 feet South and 41.14 feet East, thence running by azimuths measured clockwise from True South:-

1. Along the north side of Kumuhau Street on a curve to the right with a radius of 32.31 feet, the chord azimuth and distance being:  
110° 19' 30"                      47.78 feet;
2. 202° 45'                      292.83 feet along R.P. 564, L.C. Aw. 5875, Ap. 1 to Kaaukai;
3. 234° 30'                      10.77 feet along R.P. 567, L.C. Aw. 7087 to Kealoha;
4. 23° 12'                      53.45 feet along the remainder of Agriculture Purposes Site, Governor's Executive Order 4239;

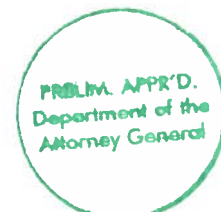

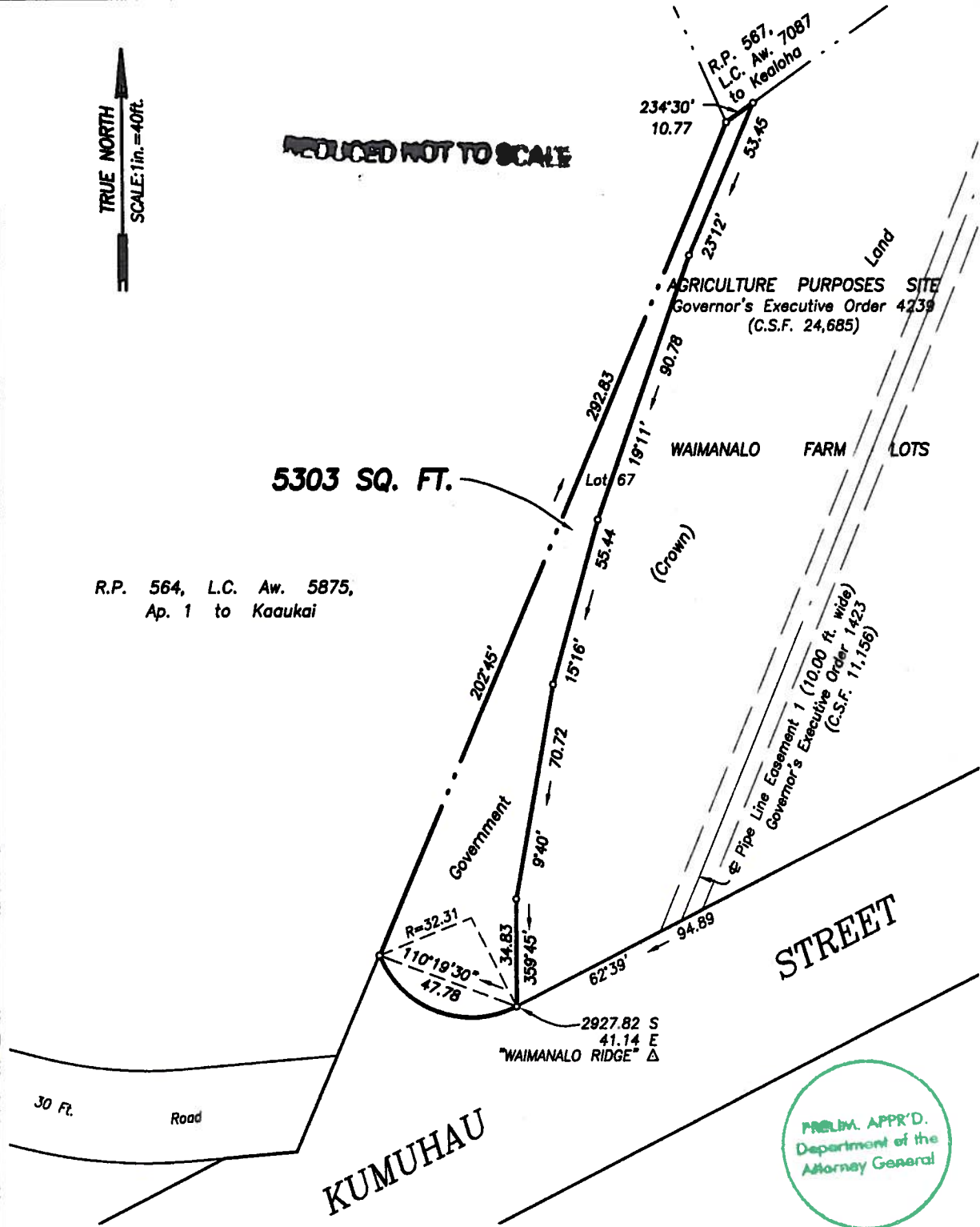
