Health Information Technology Committee
Goals and Milestones

Overview

The Health Information Technology (HIT) Committee is charged with contributing to, reviewing, and approving a statewide HIT plan. The plan should include the vision and goals, roles and responsibilities among public and private IT partners, a plan to increase inter-operability and information exchange, and identify policy levers. Additionally, the committee will develop an implementation plan for HIT strategies that support the interventions identified in the State Health Improvement Plan (SHIP) and the Population Health Plan (PHP). The implementation plan should identify supporting tools for providers, a plan to develop a Health Care Innovation dashboard, and identify quality and outcome measures.

Goals

- ✓ **Oversee the development of an innovative statewide HIT plan that supports comprehensive health care transformation for submission to CMMI by January 31, 2016.**
- ✓ **Oversee the development of an implementation plan that supports interventions identified in the State Health Improvement Plan (SHIP) and the Population Health Plan for submission by January 31, 2016.**

Guiding Principles

The recommendations in the project plan should reflect the following principles and objectives. It must:

- ✓ Include a strategy that emphasizes improving care while controlling costs.
- ✓ Identify priorities, and define metrics that will measure progress.
- ✓ Include a plan to implement the needs the other committees have identified.
- ✓ Develop plan that protects patient information and privacy.
- ✓ Incorporate provider and consumer feedback as well as cost and quality measures in the evaluation plan.
