

area of 5.000 acres (Land Office Deed S-27908), Lot 24 shall have access to Kamehameha Highway via Easement V as shown on Map 39 as set forth by Land Court Order recorded aforesaid as Document No. T-8228309, SUBJECT, HOWEVER, to any and all encumbrances that may be noted on Transfer Certificate of Title No. 1181763, more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, being designated C.S.F. No. 25,780 and dated January 23, 2020, and State of Hawaii, Land Court Map 39.

SUBJECT, HOWEVER, to the condition that upon cancellation of this executive order or in the event of non-use or abandonment of the premises or any portion thereof for a continuous period of one (1) year, or for any reason whatsoever, the State of Hawaii, Office of Hawaiian Affairs shall, within a reasonable time, restore the premises to a condition satisfactory and acceptable to the Department of Land and Natural Resources, State of Hawaii.

SUBJECT, FURTHER, to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

This executive order does not authorize the recipient of the set aside to sell or exchange or otherwise relinquish the State of Hawaii's title to the subject public land.

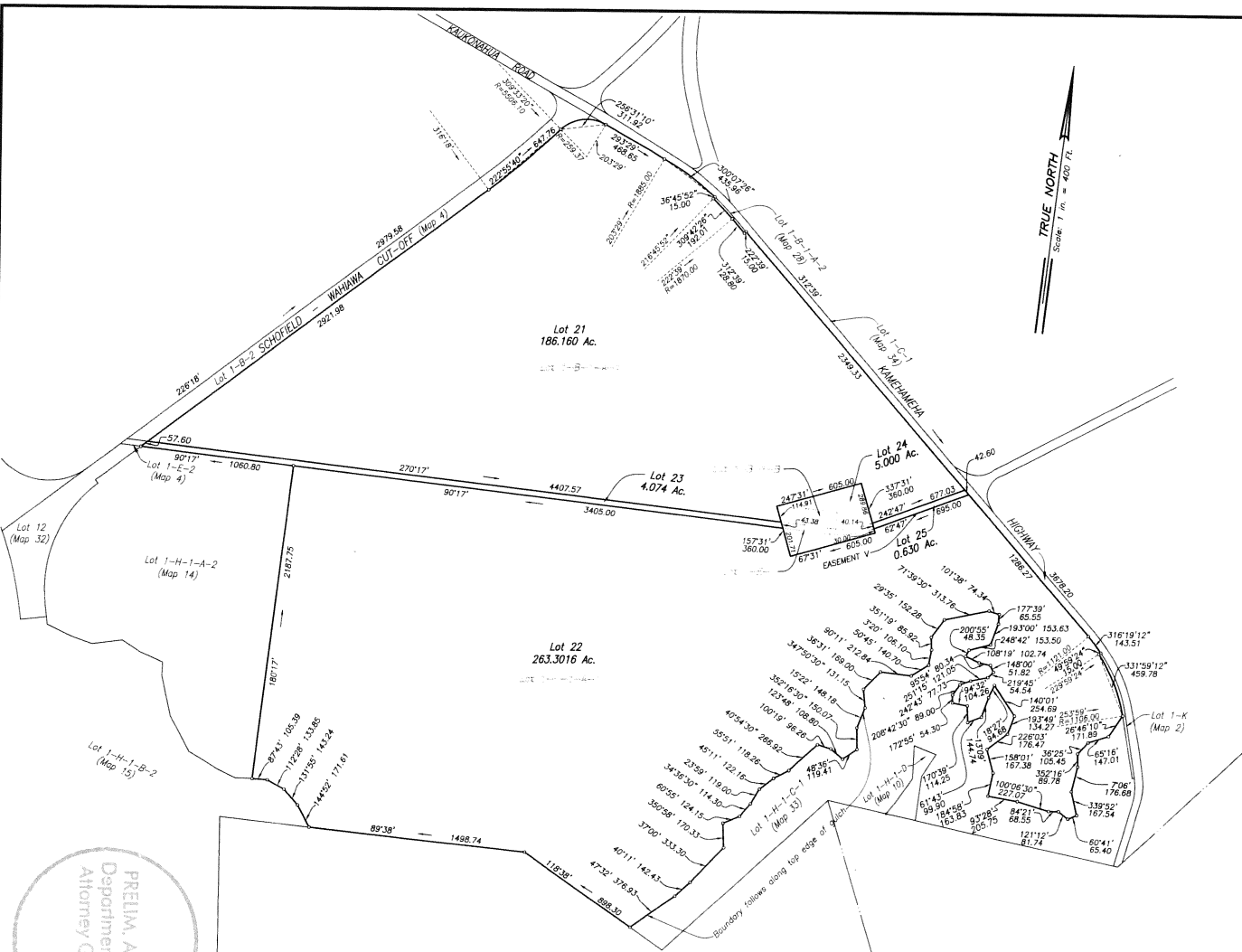
