As an Organized Crime Drug Enforcement Task Force (OCDETF) representative, I was the lead ATF investigator conducting significant multi-defendant narcotics investigations that were of regional, national, and international in scope.

As a Certified Explosives Specialist, I conducted post-blast investigations in the Honolulu Field Office and other ATF jurisdictions as assigned; provided technical assistance to state/local bomb squads and other ATF agents in the investigation of explosive incidents; provided safe disposal of recovered, purchased, seized or forfeited explosive materials; and provided explosive diagnostic capabilities at special events.

As the Assistant Team Leader, Crisis Negotiation – Special Response Team IV, I directed other crisis negotiators assigned to high risk operations; gathered intelligence and analyzed a diverse range of information to develop a negotiation strategy; and coordinated with tactical units to develop an overall critical incident plan for high risk enforcement operations.
