- Raise significant funds that support the Land Trust's ongoing work and allow the Land Trust to begin new bold land protection efforts that will have a lasting positive impact on Hawai'i.
- Oversaw the permanent protection through purchase and/or conservation easement of nine irreplaceable lands and counting (Palikea at MA'O Farms, Wai'anae, O'ahu; Mokae I, Mokae II, and Maka'alae, Hāna,

Maui; Hakipu'u Ma Kai Lo'i Kalo, Ko'olauloa, O'ahu; Kahumana Farms, Wai'anae, O'ahu; 'Ulupalakua Bat Habitat, Maui; Kawa'ewa'e Heiau & Cultural Complex, Kāne'ohe, O'ahu; 'Ōpelu Point, Kīpahulu, Maui), and oversaw strides in native ecosystem restoration and community involvement on HILT's lands.

- Project management included identifying and researching potential projects (landowners, land history, community sentiment and interested parties, risk and liability), structuring the transaction and target ownership and stewardship scenario, drafting legal agreements (Letters of Intent, Purchase/Option Agreements, Professional Service Agreements, MOUs, etc.), securing commitment from current landowner and conservation partners/future owner/steward, engaging lineal descendants and Hawaiian organizations and kupuna, securing significant private and public acquisition funds, overseeing due diligence (appraisals, Phase I Environmental Site Assessments, boundary surveys, title, archaeology, biological surveys), and coordinating all parties and funders to complete projects.
- Made significant progress in eleven active land protection projects across Hawai'i working with Native Hawaiian and broader local communities to protect open space lands of critical cultural importance, including Aina Haina Nature Preserve Expansion on O'ahu, Kaunāmano, Kawala, and Waikapuna on Hawai'i Island, and Kaluanono, and Halulu Fishpond Access on Kaua'i.
- Played a lead role in developing the O'ahu Greenprint in partnership with the Office of Hawaiian Affairs, which maps the conservation values most prioritized by O'ahu residents to help land managers, government agencies, and conservation organizations prioritize land protection and stewardship actions.
- Identified strengths and weaknesses of partner organizations and government agencies, helped partner organizations and agencies to create land management plans, and helped to build their capacity to own and manage resource properties for the betterment of Hawai'i and the perpetuation of Hawaiian culture.
