During the BEAD State Challenge Process, nonprofits, county and state entities, and internet service providers may submit information through a map-based web portal to challenge the identification of: (1) Community Anchor Institutions (CAI); (2) CAI BEAD eligibility determinations; (3) BEAD eligibility determinations for existing broadband serviceable locations (BSLs); (4) enforceable commitments; and/or (5) planned Internet service. In preparation for the formal BEAD State Challenge Process, the State of Hawai'i will conduct online and in-person briefings for each County, together with non-profits and internet service providers, to ensure our BEAD State Challenge Process participants are ready for the process. Information gathered during this process, will be used to inform the highest priority uses of BEAD grant funds. The Community Digital Navigator Program will have two components. The first component will be a statewide partnership with the Hawai'i State Public Library System (HSPLS) to include all 52 statewide locations. The second component will provide funding for eligible Community Anchor Institutions (CAI) statewide. CAIs include schools, healthcare facilities, public safety entities, higher education institutions, public housing organizations, and community support services. The Community Digital Navigator program will also support the HPHA Connections Program by providing training for community members to support common use spaces designated at HPHA facilities.
