Budget Justification

EHCC's fiscal year runs July 1, 2025 – June 30, 2026. ACT 310 funds will support operating and program expenses within this fiscal year period. The requested funds will support core operational expenses necessary to sustain programming during this

recovery period. This includes partial salary support for essential staff, utilities, and maintenance costs for our historic facility, as well as modest program expenses to ensure continuity of youth and exhibition programs. Each budget category is essential to stabilizing EHCC's capacity to deliver consistent, high-impact cultural services to the community.

EHCC respectfully requests advanced payment of the Act 310 funds due to current operational cash flow limitations and the need to maintain uninterrupted youth arts and community programming. As a small nonprofit with limited reserves, reimbursement-based funding would delay delivery of services to over 1,000 East Hawai'i residents annually. Advanced disbursement will allow us to stabilize operations and ensure program continuity during the recovery period. **Explanation of Cash Flow Projection** (Supporting Documentation for Advance Payment Request)

The attached three-year budget and cash-flow projection show that EHCC maintains a modest operating margin and anticipates temporary cash deficits early in FY 2025-26. Although total annual revenue is balanced through multiple grants and earned income, most awards are reimbursement-based or restricted to specific purposes. An advance disbursement of Act 310 funds will stabilize cash flow, enabling EHCC to maintain continuous programming and staff support during the recovery period.

Background and Summary

Applicant Background Organizational Overview

Founded in 1969 and incorporated as a nonprofit in 1980, the East Hawai'i Cultural Center (EHCC) is a Hawai'i-based 501(c)(3) organization dedicated to strengthening community through the arts, education, and cultural exchange. Located in Hilo's historic former police station and courthouse, EHCC provides free or low-cost creative programs for youth, families, kūpuna, and artists from Hawai'i and beyond. Each year, EHCC serves more than 7,000 community members and visitors, maintaining equitable access to creative learning and cultural connection for populations most affected by economic hardship and federal funding reductions.

Funding Request Purpose

Goal: To stabilize East Hawai'i Cultural Center's (EHCC) operations and sustain equitable access to arts and cultural programming for East Hawai'i residents impacted by recent federal funding reductions. Objectives: - Maintain uninterrupted community programming by providing advance operating funds to cover essential staff, utilities, and core expenses, ensuring that over 1,000 youth and adults continue to access free and low-cost creative learning opportunities. -Preserve jobs and fair compensation for local teaching artists, cultural practitioners, and program coordinators who deliver youth arts, Indigenous arts, and community workshops throughout East Hawai'i. -Ensure program continuity for Title I schools and low-income families affected by SNAP and other federal funding reductions by sustaining partnerships and removing financial barriers to participation. -Strengthen organizational resilience through stabilized cash flow and consistent delivery of exhibitions, youth programs, and cultural activities during the recovery period.

Geographic Coverage

Served Geographic Coverage

EHCC serves communities throughout East Hawai'i Island, with primary programming centered in downtown Hilo and outreach extending to Puna, Ka'ū, Hāmākua, and North Hilo districts. The organization partners with public schools, libraries, and community centers across these rural areas to ensure equitable access to arts

and cultural education. This broad geographic reach allows EHCC to engage residents from both urban and underserved rural communities who have limited access to arts resources and enrichment opportunities.

Public Purpose or Need Served

East Hawai'i Cultural Center (EHCC) serves the public by providing free and low-cost arts education, cultural programs, and exhibitions that strengthen community connection and resilience. The recent reduction of federal support—including SNAP benefit decreases, delays in federal arts funding, and reduced nonprofit access to recovery funds—has intensified the need for accessible creative programs that support families, youth, and kūpuna in East Hawai'i.

Act 310 funding will ensure that these community members continue to benefit from educational and cultural experiences that foster belonging, wellness, and creative expression, particularly for Title I school students and low-income families most affected by federal funding reductions. By maintaining continuous programming and employment for local artists and educators, EHCC fulfills a vital public purpose: sustaining equitable access to arts and culture as a means of community recovery and resilience.

Target Population Served

Target Population to Be Served

EHCC primarily serves East Hawai'i residents, with a focus on youth, families, and kūpuna who face economic or geographic barriers to arts participation. More than half of EHCC's youth program participants come from Title I public schools and households that qualify for SNAP or other assistance programs affected by federal funding reductions. Programs also reach rural communities from Puna to Honoka'a, including multi-generational families and Native Hawaiian participants who rely on accessible, culturally grounded arts education and community events.

Summary and Outcomes

Measure(s) of Effectiveness

Measures of Effectiveness

To assess the achievement of Act 310 outcomes, EHCC will track and report the following measurable indicators of program impact and service delivery:

- -Number of individuals served annually: At least 7,000 total participants, including 1,000+ youth engaged in free or low-cost programs.
- -Number of programs delivered: A minimum of 30 educational and cultural activities, including exhibitions, youth classes, community workshops, and outreach events.
- -Access and equity outcomes: At least 60% of participants from Title I schools or low-income households affected by federal funding reductions.
- -Employment and compensation: Sustain paid opportunities for 20+ local artists, teaching artists, and cultural practitioners annually.
- -Program satisfaction and impact: Achieve 90% positive participant feedback through surveys and partner evaluations demonstrating increased creative confidence, community connection, and cultural understanding.
- -Operational stability: Maintain continuous public programming throughout the fiscal year with no service interruptions.
- -Quarterly data collection and year-end reporting will provide the State with an objective basis for evaluating EHCC's effectiveness in sustaining access to arts and cultural services for East Hawai'i communities most affected by federal funding reductions.

Projected Annual Timeline

Projected Annual Timeline for Accomplishing Results or Outcomes of the Service

From July 2025 through June 2026, EHCC will continue to deliver a full year of community arts programming supported by Act 310 funds. Programming will include the Youth Arts Series (YAS), monthly Youth Art Saturdays, free school field trips and outreach, and multi-week summer arts camps integrating Hawaiian culture and environmental education. In addition, EHCC will present four to six rotating exhibitions in its main galleries and the Permanent Indigenous Art Gallery, highlighting local and Pacific Island artists and providing free public access to cultural dialogue and creative learning.

Throughout the year, Act 310 funds will stabilize staffing and operations, ensuring continuous delivery of youth programs, exhibitions, and community workshops that reach more than 7,000 residents and visitors annually. Each quarter will include hands-on activities for youth and families, professional development for teaching artists, and curated exhibitions that promote reflection, cultural exchange, and intergenerational engagement. Outcomes will be tracked through attendance data, school partnerships, and participant feedback, demonstrating measurable impact in creative access, education, and community well-being.

Quality Assurance and Evaluation Plans

Quality Assurance and Evaluation Plans

EHCC maintains a comprehensive approach to quality assurance that emphasizes accountability, community feedback, and continuous improvement. Program outcomes are tracked through attendance records, participant surveys, and partner feedback from schools, teaching artists, and community organizations. Each program cycle includes post-event evaluations assessing participant satisfaction, learning outcomes, and accessibility for Title I and low-income families. Data is reviewed quarterly by EHCC's Executive Director, Gallery Director, and Youth Arts Education Director to monitor progress toward Act 310 objectives and identify areas for improvement. Exhibition attendance, youth program participation, and outreach engagement are recorded and compared to prior years to measure growth and impact. Feedback from partners, including

Hawai'i DOE schools and cultural practitioners, informs program design and delivery. Annual reports and board reviews ensure compliance with grant requirements, while lessons learned are used to refine curriculum, expand equity of access, and strengthen program sustainability.

Scope of Work

Scope of Work, Tasks, and Responsibilities

The Act 310 funds will support EHCC in maintaining uninterrupted community programming, staff stability, and public access to arts education during the 2025–2026 fiscal year. Scope of Work:

-EHCC will deliver a full year of exhibitions, youth arts classes, community workshops, and cultural programs serving over 1,000 East Hawai'i residents. Funds will cover partial salary support for key staff, modest program costs, and essential operating expenses to ensure safe and continuous access to the Center's facilities and outreach programs.

Tasks and Responsibilities:

- -Executive Director: Oversee implementation of Act 310 objectives, fiscal management, and reporting compliance.
- -Gallery Director: Coordinate exhibitions featuring local and Indigenous artists; manage installation, visitor engagement, and educational tours.
- -Youth Arts Education Director: Deliver free and low-cost youth programs in partnership with Title I schools; supervise teaching artists and volunteers.
- -Teaching Artists and Cultural Practitioners: Lead workshops and community classes in visual and performing arts for youth, families, and kūpuna.
- -Administrative and Support Staff: Manage communications, marketing, documentation, and data collection to evaluate program outcomes.

The East Hawai'i Cultural Center (EHCC) has over five decades of experience in providing equitable, high-quality arts and cultural programming to Hawai'i Island communities. Established in 1969 and incorporated as a nonprofit in 1980, EHCC operates from Hilo's historic former police station and courthouse and serves as one of the most active community-based cultural institutions in East Hawai'i.

EHCC's leadership and staff bring extensive expertise in nonprofit administration, arts education, exhibition management, and community engagement. The organization has consistently demonstrated its ability to manage state, county, and foundation-funded projects with accountability and compliance, including multi-year grants requiring complex reporting and coordination among partners.

Summary

Through these and other grants, EHCC has demonstrated a consistent record of excellence in project management, community service delivery, and financial accountability. The organization has well-established administrative systems, including QuickBooks Nonprofit accounting, board oversight, and internal review processes, ensuring transparent and effective use of Act 310 funds.

Facilities

Facilities Description and Adequacy

East Hawai'i Cultural Center (EHCC) operates from a historic 1930s building located in downtown Hilo, leased from the County of Hawai'i. The two-story facility encompasses over 10,000 square feet and houses a professional art gallery, education classrooms, a ceramics studio, a community theatre, and Hawai'i's only public Balinese Gamelan studio.

The building is fully equipped to support the proposed Act 310-funded activities, including youth arts programs, Indigenous and contemporary art exhibitions, and community workshops. The facility includes office and meeting space for staff and volunteers, as well as storage for art materials, tools, and exhibition equipment.

EHCC maintains all necessary liability insurance, ADA access on the ground floor, and regular building maintenance coordinated with the County Parks & Recreation Department. Utilities, safety, and environmental conditions are actively monitored to ensure safe and continuous community use. The requested funds will help sustain operations within this facility by supporting essential staffing, maintenance, and program expenses that enable uninterrupted access for over 7,000 annual visitors and participants. No new facilities are required to carry out the proposed scope of work.

Proposed Staffing and Service Capacity Proposed Staffing Pattern and Administrative Capacity

The East Hawai'i Cultural Center (EHCC) will implement the proposed activities through a combination of salaried staff and contracted professionals with proven expertise in nonprofit management, arts education,

and cultural programming.

Staffing Pattern

Acting Executive Director (0.5 FTE) – Provides overall organizational leadership, fiscal management, compliance oversight, and community partnership development. Oversees all Act 310 reporting and grant deliverables.

Gallery Director (0.5 FTE) – Manages Indigenous Art Gallery and rotating exhibitions, including artist coordination, installation design, and public engagement.

Youth Arts Education Director (0.25 FTE) – Oversees the Youth Arts Series (YAS), summer camps, and outreach programs, including partnerships with Title I schools and community organizations.

Curator and Teaching Artists (Contracted) – Lead workshops, exhibitions, and special projects. Contracted professionals include experienced local artists and educators who specialize in youth engagement and culturally grounded instruction.

Administrative Oversight and Capacity

EHCC's management team has extensive experience supervising staff, coordinating multi-funder projects, and maintaining fiscal accountability through QuickBooks Nonprofit, monthly financial reviews, and Board Finance Committee oversight. Personnel policies and contracts ensure clear performance expectations, reporting lines, and equitable compensation.

All program staff are trained in child safety, cultural sensitivity, and non-discrimination practices. The Executive Director provides direct supervision, conducts quarterly evaluations, and ensures compliance with State and federal grant standards.

The proposed staffing structure is both adequate and sustainable for the scale of services described in this request, ensuring consistent, high-quality delivery across EHCC's exhibitions, education, and community programs.

These ranges reflect part-time or contracted leadership roles within EHCC's current budget capacity. Compensation is benchmarked to local nonprofit sector standards in East Hawai'i and reviewed annually by the Board of Directors.

East Hawai'i Cultural Center (EHCC) is not currently a party to any pending litigation and has no outstanding judgments.

East Hawai'i Cultural Center (EHCC) is a registered 501(c)(3) nonprofit organization in good standing with the State of Hawai'i Department of Commerce and Consumer Affairs (DCCA) and the Internal Revenue Service.

EHCC holds a current lease and operating agreement with the County of Hawai'i Department of Parks & Recreation for the historic facility that houses its galleries, classrooms, and studios, ensuring full legal access and authority to operate community programs on-site.

The organization maintains comprehensive general liability and property insurance, adheres to ADA accessibility standards for public programs, and complies with all State and County safety and operating requirements for arts and educational facilities.

EHCC's staff and contracted teaching artists possess professional qualifications in visual arts, education, and cultural practice, including degrees and certifications in art education, museum studies, and community-based arts programming.
