Narrative Statement Describing the Causal Link Between the Federal Funding Reduction and the Resulting Adverse Impacts on the Population Served

The recent reduction in federal funding was not a direct line-item cut, but it triggered events that severely strained Special Olympics East Hawai'i's operations and impacted its athletes. This began with a \$7 billion nationwide freeze on the Department of Education and related grants, initiated by the federal administration in mid-2025. This action immediately created a significant funding gap for networks supporting Special Olympics, including programs for children with disabilities and essential after-school partnerships.

To manage the unexpected shortfall, East Hawai'i programs reduced essential services in early fall 2025. These cuts include:

Reduced Athlete Mobility and Access: The organization reduced travel subsidies and postponed training camps. This directly limits athletes' access to training, skill development, and competition, hindering their growth and inclusion.

Uncertainty for Core Services: The organization is now struggling to sustain year-round athlete services, including medical screenings and Young Athlete clinics. Continued delays in federal support may put participants' health and development at risk.

In summary, the federal funding freeze created a financial disruption resulting in cuts to travel and training essential for the athletic and social well-being of East Hawai'i Special Olympics athletes.

Background and Summary

Applicant Background

Special Olympics Hawai'i has been proudly serving individuals with intellectual disabilities for over 50 years, providing year-round access to a wide range of sports, health, and community engagement opportunities. Through inclusive programming, athletes are empowered to build confidence, improve their physical and emotional well-being, and develop lifelong skills.

One of the most powerful aspects of Special Olympics is the opportunity for athletes to participate alongside community volunteers. This inclusive model fosters meaningful relationships, bridges social gaps, and creates a supportive environment where both athletes and community members benefit from positive social, emotional, and physical engagement. It's more than just sports—it's a movement for inclusion, dignity, and unity.

Funding Request Purpose One of the most significant and growing expenses is travel. The cost of roundtrip airfare to Oʻahu—where the State Games are held each June, August, and November—averages over \$200 per athlete. With increasing numbers of athletes qualifying and eager to participate, this funding would directly help us bring as many dedicated athletes as possible to compete on a statewide level, representing East Hawaiʻi with pride. Your support would directly impact the lives of our athletes by helping to remove financial barriers, ensuring every qualified individual can experience the joy, confidence, and camaraderie that comes with participation in Special Olympics. Thank you for considering our request and for supporting inclusion, dignity, and opportunity for individuals with intellectual disabilities in our community.

Geographic Coverage Served Our geographic coverage includes the districts of Hamakua, Hilo, and Puna.

Summary and Outcomes

Measure(s) of Effectiveness The East Hawaii Special Olympics will report its success using three objective Measures of Effectiveness (MOEs) to the State expending agency. The primary measure is the Travel Participation Rate (T-PR), which tracks the percentage of all eligible East Hawaii athletes who competed in the Oʻahu State Games. The goal is 100% participation, confirming the grant successfully eliminated the financial travel barrier. Secondly, the Financial Barrier Removal metric reports that a minimum of 95% of the \$15,000 grant was used directly for athlete travel costs (flights and ground transport). Finally, the Cost Efficiency Index (CEI) will calculate the average grant expenditure per participating athlete. Together, these MOEs provide the State with a clear, quantifiable assessment of the program's achievement and fiscal responsibility in maximizing athlete opportunity.

Projected Annual Timeline

The 2026 calendar for East Hawaii Special Olympics is built around three major trips to O'ahu, each requiring travel funding from the Aloha United Way ACT 310 grant. The most significant trip is the State Summer Games scheduled for early to mid-June 2026 at the University of Hawai'i and surrounding venues. This event, which includes sports like Track & Field, Swimming, and Powerlifting, represents the largest single draw on the travel budget due to the number of athletes and coaches involved. Following this, athletes will return to O'ahu in August 2026 for the 'Aukake Classic State Games at Waiau District Park in Pearl City, where they will compete in Soccer and Bocce. The travel year concludes in November 2026 with the Holiday Classic State Championship, held at Joint Base Pearl Harbor-Hickam (JBPHH) just before Thanksgiving, featuring competitions in Basketball, Bowling, and Bocce. For each of these three events, the Area Director must begin securing cost-effective group travel and accommodation three months in advance, while the Assistant Area Director must collect all financial documentation immediately following the trip to ensure timely grant reporting.

Quality Assurance and Evaluation Plans The Quality Assurance (QA) and Evaluation Plan is managed solely by the Area Director and Assistant Area Director. QA centers on the Area Director's Financial QA duties: tracking all flight and ground transportation receipts post-competition and reviewing costs monthly against the \$\\$15,000\\$ budget. The Assistant Area Director handles Program Integrity, measuring the grant's success by confirming that all qualified East Hawaii athletes who wished to attend the O'ahu events in June, August, and November were able to do so because travel was covered. The Evaluation Plan uses this data, supplemented by athlete and family testimonials, to document that the grant successfully removed the travel barrier. Finally, the Improvement Plan includes a comprehensive review in December 2026. Both Directors will analyze overall participation and booking efficiency (e.g., optimizing group flight times) to ensure future grant funds maximize athlete opportunity.

Scope of Work

The Scope of Work for the East Hawaii Special Olympics, funded by the \$15,000 Aloha United Way ACT 310 grant, is to eliminate financial barriers to competition by funding the high cost of athlete travel expenses. This ensures East Hawaii athletes can attend critical events, such as state championships and regional tournaments on Oahu, which are necessary for full program participation.

Successful execution of the grant relies solely on the Area Director and Assistant Area Director, who will assume all necessary Tasks and Responsibilities.

The Area Director will oversee Budget Allocation and Financial Tracking, ensuring the \$15,000 is prioritized for athlete travel (flights and ground transport) and that all expenditures comply with grant requirements. The

Director is also responsible for all Travel Logistics, personally securing cost-effective group travel bookings and approving arrangements.

The Assistant Area Director is tasked with Expense Documentation and Grant Reporting. This includes the meticulous collection of all receipts and invoices, compiling the necessary financial records, and submitting detailed reports to the Aloha United Way. They will also handle Impact Measurement, tracking the number of athletes who travel due to the grant and documenting the resulting positive program outcomes.
